ORDER

Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act, 2005

Shri Praveen Sakhuja vide his letter dated 29.08.2013 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against letter dated 31.07.2013 of CPIO, EIC in relation to information sought by him vide his application dated 04.07.2013.

Vide his application-dated 04.07.2013, Shri Praveen Sakhuja had sought information regarding documents exchanged between the CPIO and the deemed PIO in relation to an earlier information furnished by the CPIO to Shri Sakhuja vide his letter no. EIC / D (Q/C) / RTI / 2013-14 / 636 dated 25.06.2013. The same was denied by the CPIO vide his letter dated 31.07.2013 invoking section 8(1)(g) of the RTI Act.

As the information received by CPIO based on which information is furnished to the applicant is of confidential nature – which cannot be made available to the RTI applicants – the appeal filed by Shri Praveen Sakhuja stands disposed of without further instruction to the CPIO. Shri Sakhuja may also like to refer to Order No. EIC / D (Q/C) / 145 (52) / 2013 – 14 passed by this office on 19 September 2013.
