ORDER

Subject: Appeal made by Shri B. C. Saxena under Section 19 (1) of the Right to Information Act, 2005.

Shri B. C. Saxena vide his letter dated 23.08.2011 has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against letter dated 09.08.2011 of CPIO – EIC, for not providing the entire information requested by him vide his application dated 05.07.2011.

Vide his application-dated 05.07.2011, Shri Saxena had sought 8 numbers of information from CPIO, EIC. The information provided by the CPIO was as under.


Sl.	Information asked	Reply of CPIO
1.	How many books of new approved pattern were in stock on 1 st July 2011 prior to sale of it was effective.	The question is vague and not clear
2.	Kindly provide certified two sets of GSP form in original one being sold prior to 1 st July 2011 and second after 1 st July 2011.	GSP forms are sold by EIAs. Moreover, there forms are sold to registered exporters only.
3.	What is the estimated requirement of GSP forms for current FY 2011 -2012 (1 st July 2011 onwards) kindly provide certified copy of the file noting held for the requirement which has been approved.	16,00,000 approximately
4.	Kindly provide certified copies of the Advertisement issued by EIC for calling tenders for supply of these new GSP forms	It is noted that last tender call based on which supplies are being effected were held in 2008. After that in recent past two calls for tenders were held and the same were aborted. The applicant has not specified any date / details which would indicate as to what call of advertisement the applicant is desiring. Hence the section is unable to provide any information.
5.	Kindly supply list of vendors who submitted their tenders for supply of GSP forms against this advertisement, supported with certified copies of the tenders submitted.	
6.	Kindly provide certified copy (s) of all records, file noting held for finalisation of vendor and placing of order.	
7.	Kindly provide certified copy of the purchase order issued to the vendor for the new approved pattern GSP forms supported with administrative and financial sanction for the order	
8.	Kindly provide certified copies of the inward challan of delivery of those GSP books supplied by the vendor for sale and attestation on and after 1 st July 2011

I have gone through the records of the case and observe that the basic question (how many books of new approved pattern) is vague, which leaves the information provider to wonder as to what is really required by the applicant.

As there is no denial of information on part of CPIO, EIC, the appeal made by Shri Saxena stands disposed off.
