
Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act, 2005

Shri Praveen Sakhuja, vide his letter dated 23.09.2011, has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against letter dated 19.09.2011 of CPIO, EIC in relation to information sought by him vide his application dated 23.08.2011.

Vide his application-dated 23.08.2011, Shri Praveen Sakhuja had requested for the certified copy of approved minutes of the 105th meeting of the Council held on 27th June 2011. He had further requested to be informed of the tentative date when the same will be displayed on the website.

In response, CPIO – EIC vide his letter dated 19.09.2011 had informed Shri Sakhuja that the approved minutes will be furnished after the draft minutes are confirmed in the next meeting of the Council. For the tentative date, Shri Sakhuja was informed that the same is not applicable in view of the answer for the first query.

I have gone through the appeal made by Shri Sakhuja and observe that there is no denial of information on the part of CPIO, EIC. The appeal made by Shri Praveen Sakhuja, therefore, stands disposed off.
