
### ORDER

**Subject: Appeal made by Shri B. C. Saxena under Section 19 (1) of the Right to Information Act, 2005.**

Shri B. C. Saxena vide his letter dated 29.09.2011 has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against order dated 21.09.2011 of the CPIO – EIC for not providing information requested by him vide his application dated 22.08.2011.

Vide his letter-dated 22.08.2011, Shri Saxena had requested for copies of annual return filed by Shri Deepak Shekhar, Joint Director, EIA – Delhi during 2006 – 2011. In reply, CPIO, EIC had held that the information requested was personal in nature, the disclosure of which is liable to cause unwarranted invasion of privacy of the officer concerned and had, therefore, denied the information, citing section 8 (1) (j) of the Act.

I have gone through the appeal and observe that Shri Saxena, as a habit, files applications in a large number even on matters that are duly audited. In last few years, he has filed around 300 applications, forcing the department to commit its scarce resources and incur considerable cost both in terms of opportunity lost and manpower / postal cost. As the information sought by Shri Saxena is not only liable to cause unwarranted invasion of privacy but may also pose a threat to life / physical safety to the officer concerned, I do not find any reason to amend the order of the CPIO and the appeal made by Shri B. C. Saxena stands disposed off.
