
Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act, 2005

Shri Praveen Sakhuja vide his letter dated 17.10.2013 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against letter dated 06.09.2013 of CPIO, EIC in relation to information sought by him vide his application dated 18.07.2013.

Information sought by Shri Sakhuja vide his application-dated 18.07.2013 and supplied by CPIO vide letter dated 06.09.2013 was as under:

Sl.	Information sought	Reply of CPIO
1.	Certified copy of the instructions issued by EIC authorizing Dr. Amit Sharma those certificates sitting in Mumbai	No such information is available
2.	Details of records of such certificates of other agencies which Dr. Sharma signs sitting in Mumbai from date of signing till date	Information sought is vague without specifying the period or date. However, the applicant may consider approaching the concerned EIA with the prior notice for inspection of such records related to signing of Health Certificate by Dr. Amit Sharma.

I have gone through the appeal and do not find any infirmity with the order passed by the CPIO. However, in case Shri Sakhuja would like to avoid inspection of records, he may consider paying an amount of Rs. 3250/- to the CPIO, EIA - Mumbai by way of a demand draft drawn in favour of Export Inspection Agency - Mumbai for copies of relevant records. Shri Sakhuja may note that as per the CPIO, EIA - Mumbai, the sum of Rs. 3250/- includes the cost of manpower needed to download / retrieve / copy / scan the large number of documents requested by him. The appeal filed by Shri Praveen Sakhuja accordingly stands disposed of.
