ORDER

Subject: Appeal made by Shri B. C. Saxena under Section 19 (1) of the Right to Information Act, 2005.


Shri B. C. Saxena vide his letter dated 09.11.2011 has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against letter dated 04.11.2011 of CPIO, EIA - Delhi for not providing information requested by him vide his application dated 05.10.2011.

Vide his letter-dated 05.10.2011, Shri Saxena had requested for the following:

1. Name and address of consultants appointed / offered to be appointed from January 2011 onwards.
2. Certified copies of applications filed by applicants for engagement as consultant in the above period.
3. Date of interview.
4. Copy of advertisement published by EIA - Delhi for consultants.

In response, Shri Saxena was informed by the CPIO, EIA - Delhi that an offer for appointment was issued, that the offer was declined by person to whom it was made, that no consultant has been appointed and that the name, address and copy of his application cannot be provided as it contains third party information which is protected under section 8 (1) (j) of the RTI Act.

I have gone through the appeal and observe that Shri Saxena, as a habit, files applications in a large numbers - in last few years, he has filed around 300 applications, forcing the department to commit its scarce resources and incur considerable cost both in terms of opportunity lost and manpower / postal cost. As such, I do not find any reasons to issue any instructions to CPIO, EIA - Delhi and the appeal made by Shri B. C. Saxena stands disposed off.
