ORDER


Subject: Appeal made under Section 19 (1) of the Right to Information Act, 2005 – compliance to directions issued by the CIC – reg.

Shri Praveen Sakhuja vide his letter-dated 22.03.2012 had requested the CPIO, EIA – Delhi for (i) details of rules applicable to employees when they intend to apply to other Govt. Department, Autonomous / Statutory Body, PSU, private organisation etc., (ii) details of rules for those found guilty of violation of (i) above, and (iii) details of disciplinary proceedings to which employees are liable in case of violations.

The CPIO, EIA – Delhi transferred the application to CPIO, EIC who, while providing the information vide his letter no. EIC / D (Q/C) / RTI / 2011 – 12 dated 18.05.2012 in respect of (i) & (ii) above, informed Shri Sakhuja that there was no information on record in respect of (iii) above. Not satisfied with the answer, the applicant has filed 2nd appeal dated 18.10.2012, demanding that CPIO should furnish the information detailed at (iii) above.

Now in compliance to CIC order (case no. CIC/SS/A/2012/003697), I have gone through the case papers and observe (i) that Shri Sakhuja is habitual of filing applications in a large number on almost any matter including administrative / service matters and (ii) that CPIO can supply information only if it can be identified by the applicant.

Accordingly, the appeal filed by Shri Sakhuja stands disposed of. Shri Sakhuja is also advised to be specific while seeking information and not to misuse his right to information as a tool for harassment of the department.
