#### ORDER


**Subject: Appeal made under Section 19 (1) of the Right to Information Act, 2005 – compliance to directions issued by the CIC – reg.**

Shri Praveen Sakhuja vide his letter-dated 20.03.2012 had requested the CPIO, EIA – Delhi for information related to number of laptops, I-pods & photons purchased by EIC on or after 01.10.2009, details of their distribution in a format, source of funds etc.

The CPIO, EIA – Delhi transferred the application to CPIO, EIC who, provided the information to Shri Sakhuja vide his letter no. EIC / D (Q/C) / RTI / 2011 – 12 dated 15.05.2012. Not satisfied with the transfer of application by CPIO, EIA – Delhi to CPIO, EIC, the applicant has filed 2<sup>nd</sup> appeal dated 18.10.2012.

Now in compliance to CIC order (case no. CIC/SS/A/2012/003686), I have gone through the case papers and observe (i) that Shri Sakhuja is habitual of filing applications in a large number on almost any matter including administrative / service matters; (ii) that CPIO, EIA – Delhi had transferred the application to the CPIO, EIC as the information pertained to EIC and (iii) that the required information was furnished to Shri Sakhuja by CPIO, EIC vide his letter dated 15.05.2012.

As there is no denial of information, the appeal filed by Shri Sakhuja stands disposed of. Shri Sakhuja is also advised to seek information related to EIC from CPIO, EIC and not to misuse his right to information as a tool for harassment of the department.
