ORDER


Subject: Appeal made under Section 19 (1) of the Right to Information Act, 2005 – compliance to directions issued by the CIC – reg.

Shri Praveen Sakhuja vide his letter dated 18.10.2012 has made an appeal to the Central Information Commission against the Export Inspection Council for not providing complete information requested by him vide his application dated 30.04.2012.

Shri Sakhuja, vide letter-dated 30.04.2012, had sought for copy of notification / circular / order / any other document which classifies the posts as Group A, B, C and D. In response, the CPIO, EIC vide his letter-dated 30.05.2012 had provided the information to Shri Sakhuja and at the same time informed him that the information is also available at the website www.eicindia.gov.in under "document" etc. Shri Sakhuja has preferred an appeal insisting that the equivalent pay scales were not informed to him.

Now in compliance to CIC order (case no. CIC/SS/A/2012/003701), I have gone through the case papers and observe (i) that Shri Sakhuja is habitual of filing applications in a large number on almost any issue including administrative / service matters; (ii) that information can be provided in the manner in which it exists, (iii) that CPIO, EIC had not only provided the information but also provided the link where the information is available on the website; (iii) that identical information was sought by Shri Sakhuja from CPIO, EIA – Delhi vide an identical application; (iv) that Shri Sakhuja had not asked for current pay scales and (iv) that resources have to be committed and costs incurred by the in providing information sought by the applicants.

Since there is no denial of information, the appeal filed by Shri Sakhuja stands disposed of. Shri Sakhuja is also advised not to misuse his right to information as a tool for harassment of the department.
