### ORDER


**Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act, 2005.**

Vide his letter-dated 01.03.2012, Shri Praveen Sakhuja had requested for ten information related to marking of attendance at the head office and sub offices of EIA – Delhi. Some of the information sought was in terms of “what”. In response, the CPIO, EIA – Delhi had informed Shri Sakhuja that no information is available on records.

Not satisfied with the above, Shri Sakhuja preferred an appeal dated 21.06.2012, demanding that the information be provided to him.

Now in compliance to CIC order (case no. CIC/SS/A/2012/002984), I have gone through the case papers and observe (i) that Shri Sakhuja is habitual of filing applications in a large number on almost any matter including administrative / service matters, (ii) that “what”, “why” etc., can not be answered by CPIO, and (iii) that CPIO can supply information only if it has been properly identified by the applicant.

As the information sought was vague, I find no reason to interfere with the order of CPIO, EIA – Delhi and the appeal made by Shri Praveen Sakhuja stands disposed off. Shri Sakhuja is also advised to be specific while seeking information.
