

ORDER

Subject: Appeal made under Section 19 (1) of the Right to Information Act, 2005 – compliance to directions issued by the CIC – reg.

Shri Praveen Sakhuja vide his letter-dated 08.06.2011 had sought from the CPIO, EIA – Delhi inspection of attendance records (both biometric & manual) of the employees of EIA – Delhi for the months of January 2012 till 08.06.2012. In reply, he was informed by the CPIO that the information was voluminous and would result in diversion of resources, thereby attracting section 7(9) of the RTI Act. Shri Sakhuja has filed second appeal alleging that the information is being denied deliberately.

Now in compliance to CIC order (case no. CIC/SS/A/2012/003700), I have gone through the case papers and observe (i) that Shri Sakhuja is habitual of filing applications in a large number on almost any matter including administrative / service matters, (ii) that Shri Sakhuja was not specific while seeking the information and (iii) that for an organisation (EIA – Delhi) operating with around 66% of the sanctioned strength, I have no reasons to disagree with the contention of CPIO, EIA – Delhi that searching for entire records of all employees would result in diversion of its meagre resources. Accordingly, the appeal filed by Shri Sakhuja stands disposed of. Shri Sakhuja is also advised to be precise while seeking information and not to misuse his right to information as a tool for harassment of the department.
