
ORDER

Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act, 2005

Shri Praveen Sakhuja vide his letter dated 18.10.2012 has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against letter dated 12.04.2012 of CPIO, EIA – Delhi in relation to information sought by him vide his application dated 13.03.2012.

I have gone through the appeal made by Shri Sakhuja and observe that vide his application-dated 13.03.2012, Shri Praveen Sakhuja had requested for (i) name and designation of officer supervising maintenance of staff car, records for petrol consumption & logbook and (ii) inspection of the logbook of the staff car. In response, while providing the information at (i) above, CPIO EIA – Delhi vide his letter-dated 12.04.2012 had informed Shri Sakhuja that the logbook cannot be allowed in terms of section 8(1)(g) of the RTI Act.

The plea taken by CPIO, EIA – Delhi is not acceptable and therefore he is directed to revisit the request of Shri Sakhuja and communicate to him about inspection of the logbook within 15 days of this order.
