### ORDER

**Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act, 2005**


Shri Praveen Sakhuja vide his letter dated 11.02.2013 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against letter dated 04.12.2012 of CPIO, EIC in relation to information sought by him vide his application dated 25.10.2012 filed with EIA-Delhi.

Information sought by Shri Sakhuja vide his application-dated 25.10.2012 and the reply furnished by CPIO, EIC after its transfer to EIC, were as under:

a.	Certified copy of the file noting based on which applicant is informed that there is no information on records to provide month wise details of the petrol consumption of staff car bearing no. DL 2CQ 5859.	No file noting was held in the matter and information was provided as given by the concerned section / division.
b.	Copy of order/rule based on which the staff car is being parked at residential premises of the Director	No information on record
c.	Copy of the portion of the Rule which details parking of the staff car at residence of officer / driver after office hours and on holidays.	No information on record
d.	Details of authority who can permit parking of staff car at residential premises of officer / driver after office hours or holidays	No information on record

I have gone through the appeal filed by Shri Sakhuja and the case papers and observe (i) that the available information has been provided to Shri Sakhuja and (ii) that Shri Sakhuja is habitual of filing applications in a large number on any matter.
