ORDER


Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act, 2005

Shri Praveen Sakhuja vide his letter dated 11.02.2013 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against letter dated 04.12.2012 of CPIO, EIC in relation to information sought by him vide his application dated 25.10.2012.

Vide his application-dated 25.10.2012 filed with EIA-Delhi, Shri Praveen Sakhuja had sought copy of file noting based on which CPIO, EIC in his letter dated 16th October 2012 had claimed "No information on record". This application was forwarded by EIA-Delhi to CPIO, EIC who in turn informed Shri Sakhuja, vide his letter dated 04.12.2012, that there was no file noting. Now Shri Sakhuja has filed this appeal on the plea that CPIO has played with the words and has not supplied the information deliberately.

I have gone through the appeal filed by Shri Sakhuja and observe (i) that there is no infirmity in the order passed by the CPIO, EIC and (ii) that Shri Sakhuja is habitual of filing applications in a large number on almost any matter.

Accordingly, the appeal filed by Shri Praveen Sakhuja stands disposed of. Shri Sakhuja is also advised not to misuse his right to information as a tool for harassment of the department.
