### ORDER


**Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act, 2005**

Shri Praveen Sakhuja vide his letter dated 12.02.2014 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against CPIO, EIC in relation to information sought by him vide his application dated 25.11.2013.

Vide his application dated 25.11.2013 bearing reference EIC-13-129 submitted to EIA - Delhi, Shri Sakhuja had sought information concerning staff grievance & appeals received in EIC during the period January 2010 till 25.11.2013. The RTI Cell had sought the related records / views from the concerned CPIOs vide its letter dated 18.02.2014 and reminder dated 07.03.2014. While one CPIO has informed that the subject matter was not dealt by him, no response has been received from the other.

I have gone through the appeal and observe that the staff grievance & appeals are handled by administration. Under the circumstance, Shri Rajvinder Singh, & Shri Kannan Kasturi NS, the two DD (NT) looking after administration in EIC are hereby directed to respond to application dated 25.11.2013 of Shri Sakhuja within two weeks of receipt of this order.

With the above directions, the appeal filed by Shri Sakhuja stands disposed of.
