### ORDER


**Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act, 2005**

Shri Praveen Sakhuja vide his letter dated 12.02.2014 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against CPIO, EIC in relation to information sought by him vide his application dated 09.12.2013.

Vide his application dated 09.12.2013 bearing reference EIC-13-153, Shri Sakhuja had sought information concerning allocation of work and manpower between two DD (NT) posted at EIC. The present appeal has been filed by Shri Sakhuja as he is not satisfied with reply dated 20.12.2013 of the concerned CPIO. The RTI Cell had sought the related records / views from the concerned CPIO vide its letter dated 18.02.2014 and reminder dated 07.03.2014; however the same have not yet been produced / received.

Under the circumstance, Shri Kannan Kasturi NS, DD (NT) & CPIO is hereby directed to revisit application dated 09.12.2013 bearing reference EIC-13-153 and provide the required information to Shri Sakhuja, free of cost, within two weeks of receipt of this order.
