ORDER

Subject: Appeal made by Shri Sunil Saxena under Section 19(1) of the Right to Information Act 2005

Facts of the Case:

Shri Sunil Saxena vide his letter dated 15 Feb 2014 has made an appeal under Section 19(1) of the Right to Information Act 2005, as he was not satisfied with the reply given by CPIOs to his RTI application request dated 6 Dec 2013.

Vide his RTI request dated 6 Dec 2013 Shri Sunil Kumar had sought information on seven points in relation to Shri Kannan Kasturi, Deputy Director (NT). The information sought reads as:

1. Certified copy of the employment letter issued to Shri Kannan Kasturi for the post of DD(NT) in EIA Delhi
2. Joining report of Shri Kannan Kasturi in EIA Delhi
3. Order of transfer of Shri Kasturi DD(NT) in EIC from EIA Delhi
4. Work allocation of Shri Kannan Kasturi in EIC
5. Details of DD(NT) working in EIC other than Shri Kannan Kasturi
6. Name and Date of employment of DD(NT) mentioned at "5" above in EIC
7. Work allocation of DD (NT) listed at 5 & 6 above.

CPIO vide his letter dated 9 Dec 2013 replied to Shri Saxena stating that information at point 1 to 4 was not with his section and supplied information at point 5 to 7.

The other CPIO vide his reply dated 20 Dec 2013 cited an RTI application bearing no EIC13-108 and stated that the information has been supplied to the applicant.

The issues raised in the appeal of the applicant are he has not been provided the information and he be provided information listed at points 1 to 7 along with certified copies.

Having gone through the appeal and replies given by the CPIOs, it is observed that the information requested at Sr no 5 to 7 has been provided. In his RTI application the applicant has

not requested certified copies and while making an appeal the applicant desires certified copy as well. In this case applicant is hereby advised that the appeal raised by him is considered vis-a-vis his RTI application and since there is no request for documents in point 5-7 the applicant cannot be allowed to amend his RTI request and hence documents are not required to be provided in respect of points 5 to 7.

It is noted that CPIO, EIC in his reply dated 9 Dec 2013 has not provided the complete information in respect point no 7 wherein the work allocation of the other DD (NT) (Shri Kannan Kasturi) has not been provided.

As far as point 1 to 3 is concerned the information should be available with CPIO EIA Delhi.

Since the information sought at point 4 of the RTI application is similar to part information under point 7 which details the work allocation of DD(NT), the information needs to be provided.

Orders:

- (a) Information listed at Sr no 1 to 3 be provided by CPIO EIA Delhi
- (b) Information at Sr no 4 be provided by CPIO EIC Delhi. (The information provided for point no 3 is similar to part information at point 7)

The above information to be provided to applicant within two weeks of this order. This disposes off the appeal of Shri Sunil Kumar.
