ORDER

Subject: Appeal made by Md Zia ul Haque under Section 19(1) of the Right to Information Act 2005

Facts of the Case:

Md Zia ul Haque vide his email dated 22 May 2014 has made an appeal under Section 19(1) of the Right to Information Act 2005, as he was not satisfied with the reply given by CPIOs to his RTI application request dated 13 May 2014.

Vide his RTI request dated 13 May 2014 Md Zia ul Haque had sought information on the details of service period at EIA Kolkata .

Vide his RTI request dated 13 May 2014 Md Zia ul Haque had sought information on the details of the service period for service at EIA Kochi. The information sought reads as:

- Copy of my service book
- Copy of all leave applications and joining reports submitted by me for the period from Jan 2009 to March 2010
- Copy of the rules under which EIC/EIAs is empowered to recast the leave account (mentioning the period for which the leave account was re-casted). Kindly also mention when the alleged anomalies were detected.
- Copy of the procedure by which my leave account was re-casted along with copies of all notings made in this regard.
- Copy of the rules under which interest has not been added to my gratuity amount.
- Names of articles alleged to have lost from my custody and the procedure by which its valuation was assessed as alleged in order dated 24 April 2014 issued by Additional Director EIC
- Copy of service of its annual demand notice and documentary evidence showing that it has not been paid
- Copy of attendance registers of officers for the period from Dec 2008 till April 2010

- Copy of the order directing for inclusion of my name in the attendance register after my transfer from EIA Kochi and subsequent joining at EIA Kolkata in the month of Jan 2009
- Name of officers whose service books and /or leave account was/were re-casted after his/their retirement

CPIO EIA Kolkata vide his letter dated 29 May 2014 informed this office that since they do not have the file they are not able to provide the information on the ten points raised under RTI application

Aggrieved by the no response from CPIO the applicant raised an appeal under section 19(1) of RTI Act 2005 vide his letter dated 22 May 2014 and stated that the CPIO has not provided the information and hence he be directed to provide the same to applicant

Having gone through the appeal and comments given by the CPIO to this office, I am of the view that the applicant can be provided substantial information as requested in his RTI application. However there are certain details that CPIO EIA Kolkata would need to obtain from EIC before the same is provided to the applicant. I do not find the observation of CPIO EIA Kolkata as tenable that they are unable to provide the information since the file has been sent to EIC.

Orders:

CPIO EIA Kolkata is directed to provide the pointwise information on the RTI request raised by the applicant within 15 days of this order.
