ORDER

Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act 2005

Facts of the Case:

Shri Praveen Sakhuja vide his letter dated 26 May 2014 has made an appeal under Section 19(1) of the Right to Information Act 2005, as he was not satisfied with the reply given by CPIOs to his RTI application request dated 5 April 2014 (EIC-14-024).

Vide his RTI request dated 5 April 2014 Shri Praveen Sakhuja had sought information on the details of working of Shri Praveen Sakhuja and related issues of signatures to foreign customs. The information sought reads as:

- a. Date of suspension of Praveen Sakhuja TO(applicant) while working in EIA Delhi kindly provide certified copy of the suspension order, even if that is held by the applicant.
- b. Date from which, applicant was denied performing duties of attesting Preferential Tariff Certification at par with other officers posted in EIA Delhi. Kindly provide copy of the orders thus issued.
- c. Certified copy of those set documents last sent to foreign customs, which carry name and signature of the applicant
- d. Certified copy of the documents sent to foreign custom intimating those of withdrawal of authorization of attesting preferential tariff certification powers delegated to the applicant at par with other officers posted in EIA Delhi after action as said at 1 above
- e. Certified copy of the documents sent to foreign custom intimating those of withdrawal of authorization of attesting preferential tariff certification powers delegated to the applicant at par with other officers posted in EIA Delhi after action as said at 2 above
- f. Certified copy of the documents sent to foreign custom intimating those of withdrawal of authorization of attesting preferential tariff certification powers delegated to the applicant at par with other officers posted in EIA Delhi after his removal from services on 25.9.2013.

RTI cell CPIO EIC vide his letter dated 11 April 2014 forwarded the application to CPIO EIA Delhi and Shri B S Maadan CPIO EIC for providing information to the applicant . CPIO EIC vide his letter dated 30 April 2014 informed the applicant that information at points a and b is with EIA Delhi

and hence information would be given from EIA Delhi. For c to f information is of vague nature and upon scrutiny of documents no information could be located and hence not commented upon.

CPIO EIA Delhi on 30 April informed the applicant of information at point no 1 enclosing a copy of suspension order and for other points since there was no information available on records stated that no inputs could be given.

Aggrieved by the reply of CPIOs the applicant raised an appeal under section 19(1) of RTI Act 2005 vide his letter dated 26 May2014.

The issues raised in the appeal of the applicant are that the information provided is not provided and hence the CPIOs be instructed to provide the information a requested by applicant.

CPIOs have preferred not to raise any comment on the appeal of the applicant as they have already provided the information and they state that they have nothing more to append. Therefore the matter is being decided in this backdrop

Having gone through the appeal and replies given by the CPIOs, I am of the considered view that the applicant be provided with the information which exists as per defined under provisions of Section 2 of RTI Act 2005.

Orders:

The CPIOs may revisit the RTI request and forward a considered speaking order to the applicant within three weeks of this order.

This disposes off the appeal of Shri Praveen Sakhuja.
