ORDER

Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act 2005

Facts of the Case:

Shri Praveen Sakhuja vide his letter dated 2 June 2014 has made an appeal under Section 19(1) of the Right to Information Act 2005, as he was not satisfied with the reply given by CPIOs to his RTI application request dated 5 April 2014 (EIC-14-025).

Vide his RTI request dated 5 April 2014 Shri Praveen Sakhuja had sought information on the recruitment process at EIC Delhi. The information sought read as:

A Certified copy of the applications along with all required and submitted documents by the candidates 9four) shortlisted for skill test followed by interview held on 30 Sept 2013 for the post stenographer Gr II against advertisement no 13

B name and designation of the members of the committee assigned duty to scrutinize the applications as per requirements of RRs and advertisement. Kindly provide certified copy of recommendations

C Name and designation of member who were appointed as vigilante for supervising skill test. Kindly provide gradation granted to each participating candidate

E certified copy of the joining report of Shri Somvir Sharma

RTI cell transferred the RTI application vide their letter dated 11 April 2014 to CPIOs at EIC Delhi for providing the information to applicant.

CPIO EIC vide his letter dated 16 April 2014 informed the applicant about the information covering the entire details and also sought some charges for documents sought by applicant. The applicant vide his letter dated 12 May 2014 deposited the required fees which was provided to the applicant on 13 May 2014 to the applicant.

Aggrieved by the reply of CPIOs the applicant raised an appeal under section 19(1) of RTI Act 2005 vide his letter dated 2 June 2014.

The issues raised in the appeal of the applicant had not been provided with the information from CPIO EIC Delhi and as such there is an intentional denial on part of CPIO by concealing the information .

CPIOs have preferred not to raise any comment on the appeal of the applicant as they have already provided the information and they state that they have nothing more to append. Therefore the matter is being decided in this backdrop

Having gone through the appeal and replies given by the CPIOs, I am of the view that the applicant has been provided with information as per records.

Orders:

There is no concealment of the information by the CPIOs and as such find no infirmity in the actions of CPIOs and as such no directions are being issued.

This disposes off the appeal of Shri Praveen Sakhuja.
