ORDER

Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act 2005

Facts of the Case:

Shri Praveen Sakhuja vide his letter dated 6 June 2014 has made an appeal under Section 19(1) of the Right to Information Act 2005, as he was not satisfied with the reply given by CPIOs to his RTI application request dated 5 April 2014 2014 (EIC-14-026).

Vide his RTI request dated 5 April 2014 Shri Praveen Sakhuja had sought information on the issue of appointment of PS to Director in EIC Delhi EIA Delhi. The information sought reads as:

- a certified copy of the applications along with all required and submitted documents by the candidates shortlisted for interview held on 29 Aug 2013 for the post of PS to Director on short term contractual appointment against advertisement no 17
- b Name and designation of the members of the committee assigned duty to scrutinize the applications as per requirements in advertisements kindly provide certified copy of its recommendations
- c Name and designation of members of SSC which recommended candidature of Shri Rahul Sharma for the post
- d Certified copy of the appointment letter issued to Rahul Sharma along with all illegality certificates required as per advertisement for short term contractual appointment
- e Certified copy of the joining report of Shri Rahul Sharma
- f certified copy of the work satisfaction reports issued by his controlling officer based on which his salary is being released from date of his joining

RTI cell EIC vide his letter dated 11 April 2014 forwarded the application to two CPIOs at EIC Delhi for providing information to the applicant. One of the deemed CPIOs of EIC vide her letter dated 15 April 2014 informed the RTI cell that there was no information on records and no

inputs could be given. Deemed CPIO took such an action despite the application being transferred under section 6(3) of RTI Act 2005. The other CPIO vide his letter dated 5 May 2014 provided point-wise information and sought information and also sought charges against documents which have been sought by the applicant. The applicant deposited the money on 12 May 2014 and the CPIO EIC provided the documents on 15 May 2014.

Aggrieved by the reply of CPIOs the applicant raised an appeal under section 19(1) of RTI Act 2005 vide his letter dated 6 June 2014.

The issues raised in the appeal of the applicant are that the information provided the complete information and hence the CPIOs be instructed to provide the information as requested by applicant.

CPIOs have preferred not to raise any comment on the appeal of the applicant as they have already provided the information and they state that they have nothing more to append. Therefore the matter is being decided in this backdrop

Having gone through the appeal and replies given by the CPIOs, I am of the considered view that the applicant has been provided with the information which exists as per records.

Orders:

There is no concealment of the information by the CPIOs and as such find no infirmity in the actions of CPIOs and as such no directions are being issued.

This disposes off the appeal of Shri Praveen Sakhuja.
