### ORDER

**Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act 2005**

#### **Facts of the Case:**

Shri Praveen Sakhuja vide his letter dated 6 June 2014 has made an appeal under Section 19(1) of the Right to Information Act 2005, as he was not satisfied with the reply given by CPIOs to his RTI application request dated 21 April 2014 (EIC-14-031).

Vide his RTI request dated 21 April 2014 Shri Praveen Sakhuja had sought information on the issue of recruitments and IWSU study. The information sought reads as:

A Date of advertisement no 2014/01 in leading news papers, naming the newspaper or others if any

B Certified copy of the correspondences through which EIC has been informed by EIA Delhi Mumbai Kochi Chennai and Kolkata of vacancies for the posts of AD(T), TO and JA stating number of posts vacant and date of vacancy

C Certified copy of the document file noting held in EIC declaring vacancies of the posts mentioned at 2 in respective agency stating date of vacancy and reasons for vacancy are as framed requirements and approvals of IWSU report implemented from June 2000 in EIC/EIAs

D certified copy of the documents / file notings held in EIC for placing the advertisement for the vacancies, with approvals from Office of Chairman as required under Section 14 A. Powers and duties of the Director (including as Ex officio Secretary of the Council) of the Export (Quality Control and Inspection) Rules 1964

RTI cell transferred the RTI application vide their letter dated 21 April 2014 to CPIO of EIC. CPIO on 5 May 2014 vide his letter informed the applicant about point 1 and for other information since there was no information here was no inputs given to the applicant by CPIO EIC.

Aggrieved by the reply of CPIOs the applicant raised an appeal under section 19(1) of RTI Act 2005 vide his letter dated 2 June 2014.

The issues raised in the appeal of the applicant had not been provided with the information and CPIO has concealed the information and the applicant seeks directions that he be provided the information.

CPIOs have preferred not to raise any comment on the appeal of the applicant as they have already provided the information and they state that they have nothing more to append. Therefore the matter is being decided in this backdrop

Having gone through the appeal and replies given by the CPIOs, I am of the view that the applicant has been provided with some information as per records. However going by the appeal the applicant raises an issue that in case there is no records how the process of recruitment is going on.

**Orders:**

The CPIOs may revisit the RTI request and forward a considered speaking order to the applicant within three weeks.

This disposes off the appeal of Shri Praveen Sakhuja.
