ORDER

Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act 2005

Facts of the Case:

Shri Praveen Sakhuja vide his letter dated 2 June 2014 has made an appeal under Section 19(1) of the Right to Information Act 2005, as he was not satisfied with the reply given by CPIOs to his RTI application request dated 2 May 2014 (EIC-14-039).

Vide his RTI request dated 2 May 2014 Shri Praveen Sakhuja had sought information on the posts of Joint Director at EIC and at EIA Delhi; Chennai; Kochi; Kolkata; and Mumbai in format which is as under:

RTI cell transferred the RTI application vide their letter dated 5 May 2014 to CPIOs at EIC and at five EIAs at Delhi, Chennai, Kochi, Kolkata and Mumbai.

CPIO EIC vide his letter dated 6 May 2014 informed the applicant about the information covering the entire details though not in the format.

CPIO EIA Kolkata vide his letter dated 15 May 2014 informed the applicant about the information.

CPIO EIA Delhi vide his letter dated 20 May 2014 informed the applicant about the information.

CPIO EIA Mumbai vide his letter dated 20 May 2014 informed the applicant that they do not have any such information and hence no inputs could be given.

CPIO EIA Kochi vide his letter dated 15 May 2014 informed the applicant about the information.

CPIO EIA Chennai vide his letter dated 4 June 2014 informed the applicant about the information.

Aggrieved by the reply of CPIOs the applicant raised an appeal under section 19(1) of RTI Act 2005 vide his letter dated 2 June 2014.

The issues raised in the appeal of the applicant had not been provided with the information from CPIO EIA Mumbai whereas all other CPIOs have provided similar information to him.

CPIOs have preferred not to raise any comment on the appeal of the applicant as they have already provided the information and they state that they have nothing more to append. Therefore the matter is being decided in this backdrop

Having gone through the appeal and replies given by the CPIOs, I am of the view that the applicant has been provided with some information as per records by five CPIOs and the sixth CPIO (EIA Mumbai) has stated that they do not have any information.

Orders:

The CPIOEIA Mumbai is requested to provide for the information based on the records with their office and in case of no records being available the matter be referred to appropriate public authority under Section 6 (3) of RTI Act 2005 under intimation to all concerned.

This disposes off the appeal of Shri Praveen Sakhuja.
