ORDER

Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act 2005

Facts of the Case:

Shri Praveen Sakhuja vide his letter dated 2 June 2014 has made an appeal under Section 19(1) of the Right to Information Act 2005, as he was not satisfied with the reply given by CPIOs to his RTI application request dated 19 May 2014 2014 (EIC-14-045).

Vide his RTI request dated 19 May 2014 Shri Praveen Sakhuja had sought information on the issue of awards etc to Dr S K Saxena Director EIC Delhi . The information sought reads as:

- a Kindly provide details of the awards with monetary benefits or others bagged by Director EIC Dr S K Saxena during his tenure at EIC till date separately stating award including cash, gold, citation, trophy or any other material in any form.
- B Kindly provide detail of the institution which has conferred the award to Dr Saxena stating private, semi government, government aided body, private trust, foundation or others specify.
- C Kindly provide details of the relation of award conferring body with activities of Export Inspection Council/ Export Inspection Agency
- D Kindly provide certified copy of documents/ records starting from request to authorities for permission to get the award till information given to authorities after getting the award.
- E Kindly provide certified copy of the movable assets form filed by Dr Saxena as required under Rule 18 of CCS (Conduct) Rule applicable to him for the periods when he received the awards, this may be carried out with due consideration of Section 10 of RTI Act 2005
- F If no form has been filed as required under Rule 18 kindly provide certified copy of documents/ record/ letter which conveys that Dr Saxena is exempted from filing the form required under Rule 18.

CPIOs of EIC vide his letter dated 26 May 2014 informed the applicant that there was no information to this effect and therefore no inputs could be given on the matter. The other CPIO vide his letter dated 3 June 2014 provided details of two awards which have been bagged by Dr S K Saxena Director EIC during the tenure of his working at EIC. The other information since was not available was not provided to the applicant.

Aggrieved by the reply of CPIOs the applicant raised an appeal under section 19(1) of RTI Act 2005 vide his letter dated 6 June 2014.

The issues raised in the appeal of the applicant are that the information has not been provided by CPIO EIC and therefore the applicant has referred to the website of EIC and have stated that on web site there are two awards listed. Citing the same applicant has sought directions that he be provided the information.

CPIOs have preferred not to raise any comment on the appeal of the applicant as they have already provided the information and they state that they have nothing more to append. Therefore the matter is being decided in this backdrop

Having gone through the appeal and replies given by the CPIOs, I am of the considered view that the applicant has been provided with the information which exists as per records by the other CPIO by way of her letter dated 3 June 2014 and the contents show that the information as per available has been provided.

Orders:

There is no concealment of the information by the CPIOs and as such find no infirmity in the actions of CPIOs and as such no directions are being issued.

This disposes off the appeal of Shri Praveen Sakhuja.
