### ORDER

**Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act 2005**

#### **Facts of the Case:**

Shri Praveen Sakhuja vide his letter dated 25 June 2014 has made an appeal under Section 19(1) of the Right to Information Act 2005, as he was not satisfied with the reply given by CPIOs to his RTI application request dated 21 April 2014 (EIC-14-030).

Vide his RTI request dated 21 April 2014 Shri Praveen Sakhuja had sought information on the following points.

- 1 Certified copy of the letter of offer to Dr Reddy for joining at the post of Joint Director, stating terms and conditions.
- 2 Certified copy of the joining report of Dr Reddy in EIC, supported with attendance sheets through biometric attendance systems and manual register as required under attendance rules and instructions issued by EIC in the matter of marking attendance through biometric attendance devise and manually in register by all employees of EIC
- 3 Details of work / training handled by him or imparted to him while his working in EIC till date of his relieving from EIC. Kindly provide certified of the relieving orders issued to Dr Reddy by EIC to join other office on relieving.
- 4 Please provide the copy of leave application of Dr Reddy if any applied by him during his stay at EIC Delhi, stating clearly nature of leave, duration of leave and placed visited during the leave

RTI Cell vide their letter 21 April 2014 forwarded the RTI request to Shri Kannan Kasturi DD(NT) EIC and CPIO EIC Delhi to provide the information along with Smt Promilla in Director Cell EIC Delhi for providing the information to the applicant. Shri Kannan Kasturi DD(NT) EIC and CPIO EIC Delhi vide his letter dated 5 May 2014 provided the applicant with the details of the charges to be paid for getting the copies and provided the information to the applicant. The applicant

deposited the amount on 12 May 2014 against which on 15 May 2014 the CPIO provided the copies of documents to the applicant.

Aggrieved by the reply of CPIOs the applicant raised an appeal under section 19(1) of RTI Act 2005 vide his letter dated 25 June 2014.

The issues raised in the appeal of the applicant had not been provided with the information from the other CPIO EIC Delhi and as such there is an intentional denial on part of CPIO by concealing the information.

CPIOs have preferred not to raise any comment on the appeal of the applicant as they have already provided the information and they state that they have nothing more to append. Therefore the matter is being decided in this backdrop.

Having gone through the appeal and replies given by the CPIOs, I am of the view that the RTI request of the applicant has been addressed to in full and as such there is no further information to be provided except for training details in case any along with the attendance records.

**Orders:**

The RTI Cell EIC Delhi is requested to provide the information available as per records regarding the training imparted to Dr Reddy and attendance records, if any

This disposes off the appeal of Shri Praveen Sakhuja.
