ORDER

Subject: Appeal made by Shri Praveen Sakhuja under Section 19(1) of the Right to Information Act 2005

Facts of the Case:

Shri Praveen Sakhuja vide his letter dated 25 June 2014 has made an appeal under Section 19(1) of the Right to Information Act 2005, as he was not satisfied with the reply given by CPIOs to his RTI application request dated 6 June 2014 (EIC-14-048).

Vide his RTI request dated 6 June 2014 Shri Praveen Sakhuja had sought information on the sanctioned strength of EIC and the request that the copies of appointment letters be provided for personnel who have been posted at EIC.

Shri R M Mandlik Deputy Director and CPIO EIC replied to the applicant on 10 June 2014 that information sought was vague and the applicant was requested for providing the specific information requirement so as to enable CPIO to provide information.

Aggrieved by the reply of CPIOs the applicant raised an appeal under section 19(1) of RTI Act 2005 vide his letter dated 25 June 2014.

The issues raised in the appeal of the applicant had not been provided with the information from CPIO EIC Delhi and as such there is an intentional denial on part of CPIO by concealing the information.

CPIOs have preferred not to raise any comment on the appeal of the applicant as they have already provided the information and they state that they have nothing more to append. Therefore the matter is being decided in this backdrop.

Having gone through the appeal and replies given by the CPIOs, I am of the view that the RTI request of the applicant deals with the sanctioned strength vis a vis the men in position at EIC.

Orders:

The CPIO EIC Delhi is requested to provide the information available as per records regarding the man in position and sanctioned strength and details of vacancy, if any
This disposes off the appeal of Shri Praveen Sakhuja.
