### ORDER

**Subject: Appeal made by Shri Parveen Kumar under Section 19 (1) of the Right to Information Act 2005.**

#### **Facts of the Case:**

Shri Parveen Kumar vide his letter dated 01 September 2014 has made an appeal under Section 19(1) of the Right to Information Act 2005, against the reply given by CPIO to his RTI application dated 07 July 2014.

Vide his RTI application dated 07 July 2014, Shri Parveen Kumar had sought inspection of complete records of ACR/APAR for the year 2011-12, 2012-13, 2013-14.

CPIO EIA – Delhi, vide her letter dated 11 July 2014 transferred the application to EIC stating the legal matter. CPIO, EIC informed applicant that he is not the custodian of the information sought and transferred the RTI application to CPIO, EIA – Delhi vide letter dated 21 July 2014.

Aggrieved by the reply of CPIO the applicant raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 01 September 2014.

The issue raised in the appeal of the applicant is that the authorities are intentionally blocking the information.

Having gone through the appeal and reply given by CPIOs, I am of the view that RTI request of the applicant deals with the inspection of his ACR/APAR for the year 2011-12, 2012-13 and 2013-14.

#### **Orders:**

The CPIO, EIA- Delhi is directed to offer the inspection of ACR/APAR of applicant for the year 2011-12, 2012-13 and 2013-14 within 15 days of this order as per his RTI application dated 07 July, 2014
