ORDER

Subject: Appeal made by Shri Parveen Kumar under Section 19 (1) of the Right to Information Act 2005.

Facts of the Case:

Shri Parveen Kumar vide his letter dated 01 September 2014 has made an appeal under Section 19(1) of the Right to Information Act 2005, against the reply given by CPIO to his RTI application request dated 08 July 2014.

Vide his RTI application dated 08 July 2014, Shri Parveen Kumar had sought information regarding appointment of Sh. Amit Sharma, Joint Director.

CPIO, EIC vide his letter dated 23rd July 2014 informed the applicant that the information sought is not clear/ vague and applicant may specify the records he desires for inspection.

Aggrieved by the reply of CPIO, the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 01 September 2014.

The issue raised in the appeal of the applicant is that he may be allowed for inspection of records/ information & certified copy thereafter.

CPIO have preferred not to raise any comment on the appeal of the applicant as the information sought is not clear/ vague and applicant may specify the records for inspection.


Therefore the matter is being decided in this backdrop.

Orders:

After going through the RTI application and reply by CPIO, I find that CPIO has already clarified that applicant has to clearly specify the records which he desires to inspect.

I find no infirmity in the reply of CPIO and therefore dispose the appeal without any further directions to CPIO.

This disposes off the appeal of Shri Parveen Kumar.
