ORDER

Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act 2005.

Facts of the Case:

Shri Praveen Sakhuja vide his letters dated 09 September 2014 has appealed under Section 19(1) of the Right to Information Act 2005, against the replies given by CPIOs to his RTI application request No. EIA-14-056 and EIA-14-057 both dated 14 July 2014.

Vide his RTI applications No. EIA-14-056 and EIA-14-057 both dated 14 July 2014, Shri Praveen Sakhuja had sought information regarding his suspension on 29 October 2012 & reduction to lower post of Junior Scientific Assistant from Technical officer on 26 August 2013.

CPIO, EIA - Delhi and CPIO, EIC vide their letters dated 25 August 2014 has provided the information to applicant.

Aggrieved by the reply of CPIO, the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letters dated 09 September 2014.

The issue raised in the appeal of the applicant is that CPIO, EIC has not enclosed any copy of letter of EIA - Delhi as stated in his letter dated 25 August 2014 and that the authorities are intentionally concealing the information.

Having gone through the appeal and the information provided by the CPIOs, I am of the view that there is no denial or concealment of information in this regard by CPIOs. The response to RTIs of applicant is already provided by CPIO, EIA - Delhi. The copy of both letters both dated 25 August 2014 issued by CPIO, EIA- Delhi are enclosed once again.

Orders:

I find no infirmity in the reply of CPIO, EIC and therefore dispose the appeal without any further directions to CPIO, EIC.

This disposes off the appeal of Shri Praveen Sakhuja.
