ORDER

Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act 2005.

Facts of the Case:

Shri Praveen Sakhuja vide his letter dated 09 September 2014 has made an appeal under Section 19(1) of the Right to Information Act 2005, against the reply given by CPIO to his RTI application request dated 31 July 2014.

Vide his RTI application dated 31 July 2014, Shri Praveen Sakhuja had sought information regarding information for travel of Director EIC to Switzerland and Bangkok in month of July 2014.

CPIO, EIC vide his letter dated 19 August 2014 provided the information to applicant and vide his letter dated 28 August 2014, provided the certified copies of records, all related documents for travel of Director, EIC to Switzerland.

Aggrieved by the reply of CPIO, the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 09 September 2014.

The applicant, in his appeal, has requested to provide the copy of mail message and approval of Competent Authority for travel.


Having gone through the appeal and reply submitted by CPIO, EIC, I am of the view that CPIO, EIC has provided all the relevant information as requested by applicant.

Orders:

It is observed that attempt has been made on the part of CPIO, EIC to provide all the relevant documents requested by applicant in his RTI application. Seeking specific papers later on based on receipt of documents in reference to a particular RTI can not be considered part of same RTI application. Therefore, either the applicant should be specific while seeking information or he should file separate/fresh RTI for seeking further information. However, in the spirit of RTI, the instant

appeal is disposed off with the direction to CPIO, EIC to provide copy of e mail dated 05 May 2014 to the applicant free of cost within 15 days of this order. This should not be treated as precedence to seek further additional information under same RTI application ambit in future.

This disposes off the appeal of Shri Praveen Sakhuja.
