Subject: Appeal made by Shri Parveen Kumar under Section 19 (1) of the Right to Information Act 2005.

Facts of the Case:

Shri Parveen Kumar vide his letter dated 02 October 2014 has made an appeal under Section 19(1) of the Right to Information Act 2005, as he was not satisfied with the reply given by CPIO to his RTI application request dated 02 September 2014.

Vide his RTI request dated 02 September 2014, Shri Parveen Kumar had sought information regarding letter no. EIC/D(Q/C)22(Accounts)/2014/3431 dt. 10th July 2014 issued to EIA-Delhi.

CPIO EIC Vide his letter dated 09 September 2014 provided the information to the applicant.

Aggrieved by the reply of CPIO the applicant raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 02 October 2014.

The issue raised in the appeal of the applicant is that the information has not been provided to the applicant and therefore the CPIOs be directed to provide the information


CPIOs have preferred not to raise any comment on the appeal of the applicant as they have already provided the information and they state that they have nothing to append.

Therefore the matter is being decided in this backdrop.

Orders:

In this case, I find no infirmity in the reply of CPIO relating to concealment of information and therefore dispose the appeal without any directions to CPIO EIC.

This disposes off the appeal of Shri Parveen Kumar.
