ORDER

Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act 2005.

Facts of the Case:

Shri Praveen Sakhuja vide his letter dated 26 September 2014 has made an appeal under Section 19(1) of the Right to Information Act 2005, against the reply given by CPIO to his RTI application request dated 22 July 2014.

Vide his RTI application dated 22 July 2014, Shri Praveen Sakhuja had sought information regarding travel of Director, EIC to other countries from 1st January 2014 till date.

CPIO, EIC vide his letter dated 21 August 2014 provided the information to applicant.

Aggrieved by the reply of CPIO, the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 26 September 2014.


The issue raised in the appeal of the applicant is that the CPIO has denied the information related to travel to Geneva.

Having gone through the appeal and the information provided by the CPIO, EIC, I am of the view that there is no denial or concealment of information in this regard by CPIO and the request of applicant has been addressed by providing the information. The complete details are already provided by CPIOs to applicant vide letters dated 19 August 2014, 28 August 2014, 17 October 2014, 1 October 2014 and 28 October 2014 in response to his previous RTI applications dated 26 September 2014 and 02 August 2014.

Orders:

I find no infirmity in the reply of CPIO, EIC and therefore dispose the appeal without any further directions to CPIO, EIC.

This disposes off the appeal of Shri Praveen Sakhuja.
