ORDER

Subject: Appeal made by Shri. Praveen Sakhuja under Section 19 (1) of the Right to Information Act 2005.

Facts of the Case:

Shri Praveen Sakhuja vide his letter dated 8 December 2014 has made an appeal under Section 19(1) of the Right to Information Act 2005, against the reply given by CPIO to his RTI application request dated 28 November 2014.

Vide his RTI application dated 28 November 2014, Shri Praveen Sakhuja had sought information regarding amounts deposited by Director, EIC for the period 15.7.2011 to 30.8.2011.

CPIO, EIC vide his letter 3 December 2014 provided the information to applicant.

Aggrieved by the reply of CPIO, the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 8 December 2014.

The applicant, in his appeal, has requested to provide specific information.


CPIO, EIC have preferred not to raise any comment on the appeal of the applicant as they have already provided the information and they state that they have nothing to append.
