#### ORDER

**Subject: Appeal made by Shri. Praveen Sakhuja under Section 19 (1) of the Right to Information Act 2005.**

#### **Facts of the Case:**

Shri Praveen Sakhuja vide his letter dated 9 January 2015 has made an appeal under Section 19(1) of the Right to Information Act 2005, against his RTI application request dated 7 November 2014.

Vide his RTI application dated 7 November 2014; Shri Praveen Sakhuja had sought information regarding Advertisement No. 17 issued by EIC and recruitment rules.

The applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 9 January 2015 stating that CPIO has not provided the information as requested.

CPIO, EIC vide his letter 16 January 2015 provided the information to applicant.

CPIO, EIC have preferred not to raise any comment on the appeal of the applicant as they have already provided the information and they state that they have nothing to append.

There is no denial or concealment of information in this regard by CPIO and the request of applicant have been addressed by providing the information.
