ORDER

Subject: Appeal made by Shri. Praveen Sakhuja under Section 19 (1) of the Right to Information Act 2005.

Facts of the Case:

Shri Praveen Sakhuja vide his letter dated 9 January 2015 has made an appeal under Section 19(1) of the Right to Information Act 2005, against the reply given by CPIO to his RTI application request dated 22 September 2014.

Vide his RTI application dated 22 September 2014; Shri Praveen Sakhuja had sought information regarding list and date of purchase order, delivery and installation of equipments purchases by EIAs.

CPIO, EIC vide his letter dated 05 November 2014 provided the information to applicant.

Aggrieved by the reply of CPIO, the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 09 January 2014.

The applicant, in his appeal, has requested to provide all the information as requested.

CPIO, EIC have preferred not to raise any comment on the appeal of the applicant as they have already provided the information and they state that they have nothing to append.
