Subject: Appeal made by Sh. Rajiv Raizada under Section 19 (1) of the Right to Information Act 2005.

Facts of the Case:

Sh. Rajiv Raizada vide his letter dated 16 February 2015 has made an appeal under Section 19(1) of the Right to Information Act 2005, against the reply given by CPIO to his RTI application request dated 4 January 2015.

Vide his RTI application dated 4 January 2015; Sh. Rajiv Raizada had sought information regarding his vigilance clearance and tax remitted to income tax authorities.

CPIO, EIC-Delhi vide letter dated 8 January 2015 provided the information to applicant.

Aggrieved by the reply of CPIO, the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 16 February 2015.


The applicant, in his appeal, has requested to provide the requested information as per his RTI application.
