#### ORDER

**Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act 2005.**

#### **Facts of the Case:**

Shri Praveen Sakhuja vide his letter dated 01 April, 2015 has made an appeal under Section 19(1) of the Right to Information Act 2005 against his RTI application request dated 11 February, 2015.

Vide his RTI application dated 11 February, 2015; Shri Praveen Sakhuja had sought information regarding advertisement related to tenders for supply of laboratory equipment/instruments for Pilot Test House, Mumbai.

CPIO, Mumbai vide letter dated 25 February, 2015 and 12 March 2015 provided the information to applicant.

Aggrieved by the reply of CPIO, EIA - Mumbai, applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 01 April, 2015.

The issue raised in appeal of the applicant is that the certified copy of approval of specifications and approval of revision of specification is not provided which was requested at point no. 4 and 5 of his RTI application.

Having gone through the appeal and the information provided by the CPIO, EIA - Mumbai, I am of the view that there is no denial or concealment of information in this regard by CPIO. However, the copies of documents which were requested by applicant were not provided.

#### Orders:

CPIO Mumbai is directed to provide the certified copies of documents as requested by applicant at point no. 4 and 5 of his RTI application dated 11 February, 2015 without any charge within 10 days of issuance of this order.

This disposes off the appeal of Shri. Praveen Sakhuja.
