ORDER

Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act 2005.

Facts of the Case:

Shri Praveen Sakhuja vide his letter dated 20 July 2015 has made an appeal under Section 19(1) of the Right to Information Act 2005, against his RTI application request dated 30 May 2015.

Vide his RTI application dated 30 May 2015; Shri Praveen Sakhuja had sought the information regarding Invitation card, program schedule, key note address related to Golden Jubilee Celebration of EIC.

CPIO, EIC vide letter dated 30 June 2015 provided the information to applicant.

Aggrieved by the reply of CPIO, EIC-Delhi the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 20 July 2015.

The applicant, in his appeal, has requested to provide the information as requested.

CPIO, EIC has preferred not to raise any comment on the appeal of the applicant as they have already provided the information to applicant and they state that they have nothing to append.
