ORDER

Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act 2005.

Facts of the Case:

Shri Praveen Sakhuja vide his letter dated 20 July 2015 has made an appeal under Section 19(1) of the Right to Information Act 2005, against his RTI application request dated 1 April 2015.

Vide his RTI application dated 1 April 2015; Shri Praveen Sakhuja had sought the information regarding date and year of establishment of Export Inspection Council, and present HQ of EIC.


The applicant, in his appeal, has requested to provide the information as requested.
