**Subject: Appeal made by Shri. Praveen Sakhuja under Section 19 (1) of the Right to Information Act 2005.**

#### **Facts of the Case:**

Shri Praveen Sakhuja vide his letter dated 24 November 2014 has made an appeal under Section 19(1) of the Right to Information Act 2005, against the reply given by CPIO to his RTI application request dated 27 September 2014.

Vide his RTI application dated 27 September 2014, Shri Praveen Sakhuja had sought information regarding appointment and joining of Smt. Seema Shukla, AD(Tech).

CPIO, EIC vide his letter 17 October 2014 provided the information to applicant.

Aggrieved by the reply of CPIO, the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 24 November 2014.

The applicant, in his appeal, has requested to provide the information regarding work allocation of Seema Shukla by CPIO, EIC since she is working in EIC with effect from 03.01.2011.

CPIO, EIC have preferred not to raise any comment on the appeal of the applicant as they have already provided the information and they state that they have nothing to append.

Having gone through the appeal and reply submitted by CPIO, EIC and CPIO EIA - Delhi, it is observed that RTI application of the applicant has been transferred between EIC and EIA - Delhi but there is no denial or concealment of information in this regard by CPIO and the request of applicant have been addressed by providing the information except the information requested at S. No. 3 of the RTI application dated 27 September 2014.

#### **Orders:**

The CPIO, EIC is directed to provide the information as requested at S. No. 3 of the RTI application within 15 days of this order as per his RTI application dated 27 September, 2014

This disposes off the appeal of Shri. Praveen Sakhuja.
