Subject: Appeal made by Mr. Sheik Ali Hussain under Section 19 (1) of the Right to Information Act 2005.

Facts of the Case:

Mr. Sheik Ali Hussain vide his letter dated 13 July 2015 has made an appeal under Section 19(1) of the Right to Information Act 2005, against his RTI application request dated 8 June 2015.

Vide his RTI application dated 8 June 2015; Mr. Sheik Ali Hussain had sought the permission to check office documents from 1st April 2014 to 30th March 2015.

CPIO, EIA-Chennai vide letter dated 8 July 2015 provided the information to applicant.

Aggrieved by the reply of CPIO, EIA-Chennai the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 13 July 2015.
