#### ORDER

**Subject: Appeal made by Shri Bhagwan Chand Saxena under Section 19 (1) of the Right to Information Act 2005.**

#### **Facts of the Case:**

Shri Bhagwan Chand Saxena vide his letter dated 7 August 2015 has made an appeal under Section 19(1) of the Right to Information Act 2005, against his RTI application request dated 20 July 2015.

Vide his RTI application dated 20 July 2015; Shri Bhagwan Chand Saxena had sought the information regarding engagement of Consultants against advertisement in Sep, 2011.

CPIO, EIC vide letter dated 29 July 2015 provided the information to applicant.

Aggrieved by the reply of CPIO, EIC the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 7 August 2015.


The applicant, in his appeal, has requested to provide the information as requested.

CPIO, EIC has preferred not to raise any comment on the appeal of the applicant as they have already provided the information to applicant and they state that they have nothing to append.
