### ORDER

**Subject: Appeal made by Shri Praveen Sakhuja under Section 19 (1) of the Right to Information Act 2005.**

#### **Facts of the Case:**

Shri Praveen Sakhuja vide his letter dated 18 August 2015 has made an appeal under Section 19(1) of the Right to Information Act 2005, against his RTI application request dated 11 June 2015.

Vide his RTI application dated 11 June 2015; Shri Praveen Sakhuja had sought the information regarding number of vacancies with details of posts as on 01.01.2010 in reserved categories and their verification.

CPIO, EIC vide letter dated 30 June 2015 provided the information to applicant.

Aggrieved by the reply of CPIO, EIC the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 18 August 2015.

The applicant, in his appeal, has requested to provide the information as requested.
