#### ORDER

**Subject:** Appeal made by Shri. M T Babu under Section 19 (1) of the Right to Information Act 2005.

#### **Facts of the Case:**

Shri M T Babu vide his letter dated 27 November 2014 has made an appeal under Section 19(1) of the Right to Information Act 2005, against the order given by FAA to his appeal dated 23 April 2014.

Vide his RTI application dated 6 February 2014, Shri M T Babu had sought information regarding disbursement of pension. CPIO, EIA-Kochi vide his letter dated 11 February 2014 and CPIO, EIC vide letter dated 10 March, 2014 provided the information to applicant.

Aggrieved by the reply of CPIO, the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 10 April 2014.

FAA vide order dated 23 April disposed off the appeal with directions to CPIO Kochi.

Aggrieved by the order of FAA, the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 27 November 2014.

The applicant, in his appeal, has requested that necessary corrections may be made in the order of FAA point no. c of his RTI application.


The previous FAA, EIC have preferred not to raise any comment on the appeal of the applicant as they have already provided the information and they state that they have nothing to append.

Having gone through the appeal, I am of the considered view that the application was considered in the spirit of RTI Act and the information requested is provided to the applicant. There is no denial or concealment of information in this regard by CPIO and the request of applicant have been addressed by providing the information. The change of words by FAA has not resulted in denying any information to applicant.

#### **Orders:**

I find no infirmity in the reply of CPIO, EIC and therefore dispose the appeal without any further directions to CPIO, EIC.
