**Subject: Appeal made by Shri Sarvesh Chandra Bhatnagar under Section 19 (1) of the Right to Information Act 2005.**

### Facts of the Case:

Shri Sarvesh Chandra Bhatnagar vide his letter dated 7 September 2015 has made an appeal under Section 19(1) of the Right to Information Act 2005, against his RTI application request dated 24 July 2015.

Vide his RTI application dated 24 July 2015; Shri Sarvesh Chandra Bhatnagar had sought the information regarding his MACP.

CPIO, EIA-Mumbai vide letter dated 31 August 2015 provided the information to applicant.

The applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 7 September 2015, stating that he has not received any information from CPIO, EIA-Mumbai.

CPIO, EIA-Mumbai has preferred not to raise any comment on the appeal of the applicant as they have already provided the information to applicant and they state that they have nothing to append. A copy of letter dated 31.08.15 forwarded by CPIO, EIA-Mumbai to applicant is enclosed.

I find no infirmity in the reply of CPIO, EIA-Mumbai and therefore dispose the appeal without any further directions to CPIO, EIA-Mumbai.
