Subject: Appeal made by Shri Md. Zia-ul-Haque under Section 19 (1) of the Right to Information Act 2005.

Facts of the Case:

Shri Md. Zia-ul-Haque vide his e-mail dated 16 October 2015 has made an appeal under Section 19(1) of the Right to Information Act 2005, against his RTI application request dated 21 September 2015.
