Subject: Appeal made by Mrs. Darshana H. Trivedi under Section 19 (1) of the Right to Information Act 2005.

Facts of the Case:

Mrs. Darshana H. Trivedi vide her letter dated 06 April 2016 has made an appeal under Section 19(1) of the Right to Information Act 2005, against his RTI application request dated 16 February 2016.

Vide her RTI application dated 16 February 2016; Mrs. Darshana H. Trivedi had sought the information regarding service rules for the employees of Export Inspection Agencies which were approved in the 11th meeting of the Export Inspection Council on 30.6.1966.

CPIO, EIC vide letter dated 14 March 2016 provided the information to applicant.

Aggrieved by the reply of CPIO, EIC the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide her letter dated 06 April, 2016.

The applicant, in her appeal, has requested to provide the complete documents.


CPIO, EIC has preferred not to raise any comment on the appeal of the applicant as they have already provided the information to applicant and they state that they have nothing to append.
