ORDER

Subject: Appeal made by Shri Bhagwan Chand Saxena under Section 19 (1) of the Right to Information Act 2005.

Facts of the Case:

Shri Bhagwan Chand Saxena vide his letter dated 15 September, 2016 has made an appeal under Section 19(1) of the Right to Information Act 2005, against his RTI application request dated 01 August, 2016.

Vide his RTI application dated 01 August, 2016; Shri Bhagwan Chand Saxena had sought the information regarding Details of Engagement of Manpower through Security Agency.

CPIO, EIC vide letter dated 22 August, 2016 provided the information to applicant.

Aggrieved by the reply of CPIO-EIC, the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his letter dated 15 September, 2016.


The applicant, in his appeal, has requested to provide the information as requested.
