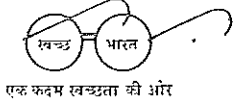

## ORDER

**Subject:** Appeal made by Shri Ranjan Mohanty, Delhi under Section 19(1) of the Right to Information Act, 2005 – reg.

### **Facts of the Case:**

Shri Ranjan Mohanty, Delhi vide his application dated 30<sup>th</sup> January, 2019 has made an appeal under Section 19(1) of the Right to Information Act, 2005, against his RTI application request dated 16<sup>th</sup> November, 2018.

Vide his RTI application dated 16<sup>th</sup> November, 2018, Shri Ranjan Mohanty, Delhi had sought the information regarding Certified Copy of "Export Inspection Agency Employees (Classification, Control & Appeal) Rules, 1978 along with the corrections / Amendments made thereunder till date.

CPIO, EIC vide letter dated 17<sup>th</sup> December, 2018, provided the information to the applicant.

The applicant vide letter dated 30<sup>th</sup> January 2019, has appealed that he has not received the response from CPIO, EIC.

CPIO, EIC has preferred not to raise any comment on the appeal of the applicant as they have already provided the information to the applicant and they state that they have nothing to append.
