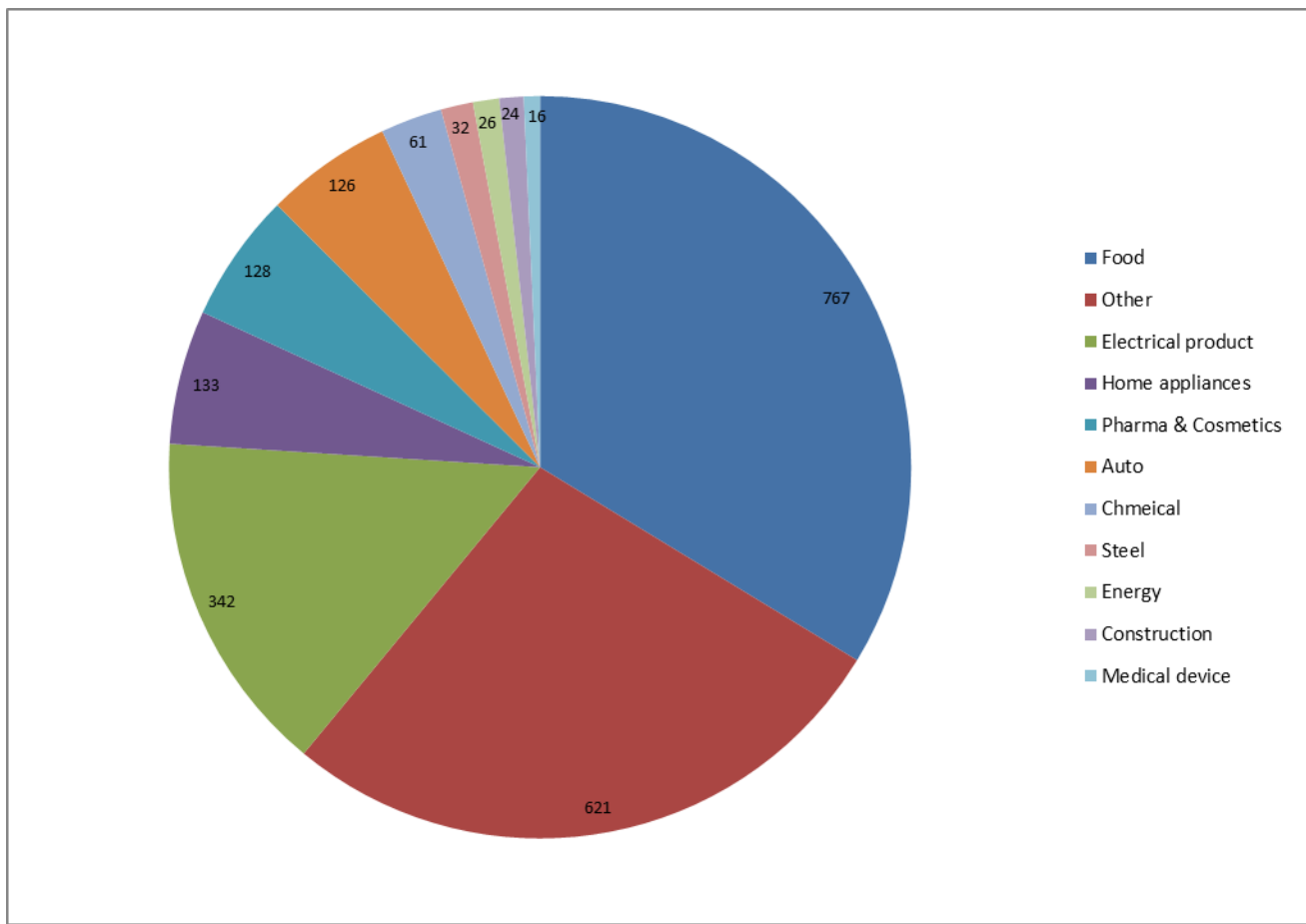

At a Glance

The total number of notifications issued by the various WTO-member countries from 1st of February 2014 to 31st January 2015 was **2276**. Out of these **2276** notifications, 532 were active notifications that were of relevance for India. These 532 were relevant to India because the products prescribed in these notifications were of India’s export interest to that particular country or to the world. These notifications were sent to their respective stakeholders for comments. Based on the feedback received from stakeholders and desktop research, in case of 42 notifications, a draft comment on each of these notifications were sent by Export Inspection Council (EIC) to the respective enquiry points. ASL analyzed these notifications to study the impact for Indian industry and sought comments from industry to ensure that there is no problem of market access for these products.

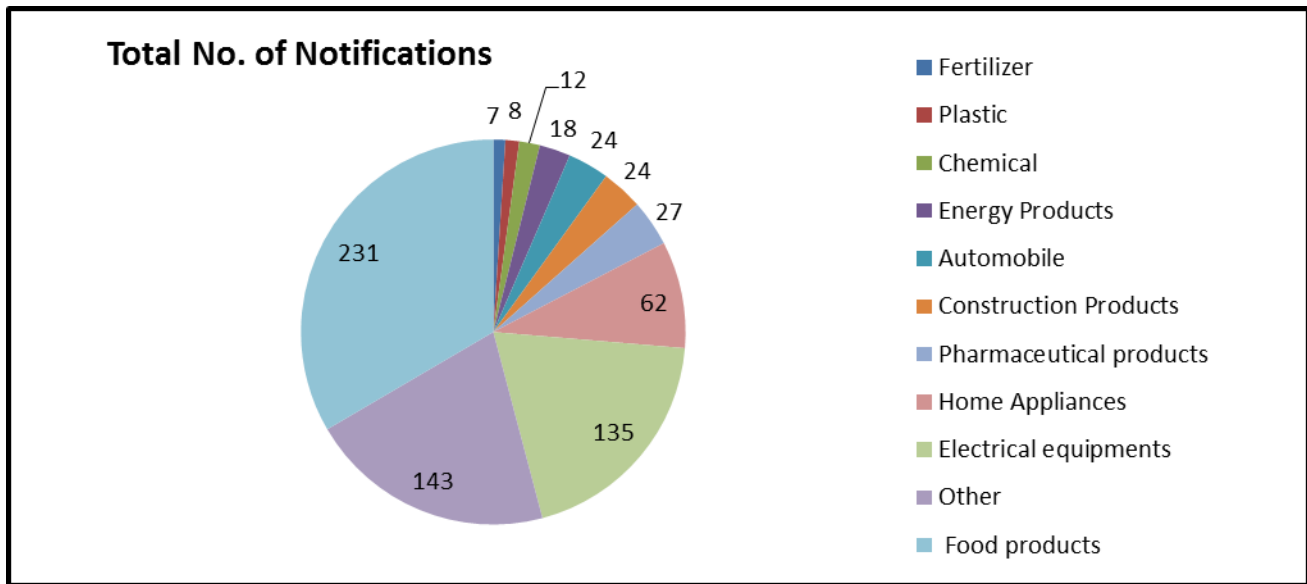
Total Number of Notifications from 1st of Feb’14 to 31st of Jan’15

Part I: 1st February 2014 to 30th April 2014

The total number of notifications issued by the various WTO-member countries from 1st of February 2014 to 30th April 2014 was 691. ASL analyzed these notifications to study the impact for Indian industry and sought comments from industry to ensure that there is no problem of market access for these products.



Out of the 691 notifications that were analyzed, 231 were on food, 135 were on electrical equipment, 62 concerned home appliances, 27 were on pharmaceutical products, 24 were on automobile products, 24 were on construction products, 18 were on energy products, 12 were on chemicals, 8 were on plastics, 7 were on fertilizer and the rest 143, were in respect to textiles, tobacco, gas containers, iron & steel, dairy products, machinery appliances, cosmetics, medical devices, dyes, toys and mattresses so on and so forth.

Out of these 691 notifications, 129 were active notifications that were of relevance for India. These 129 were relevant to India because the products prescribed in these notifications were of India's export interest to that particular country or to the world. Please refer **Annex A** for the list of 129 notifications which are relevant to India.

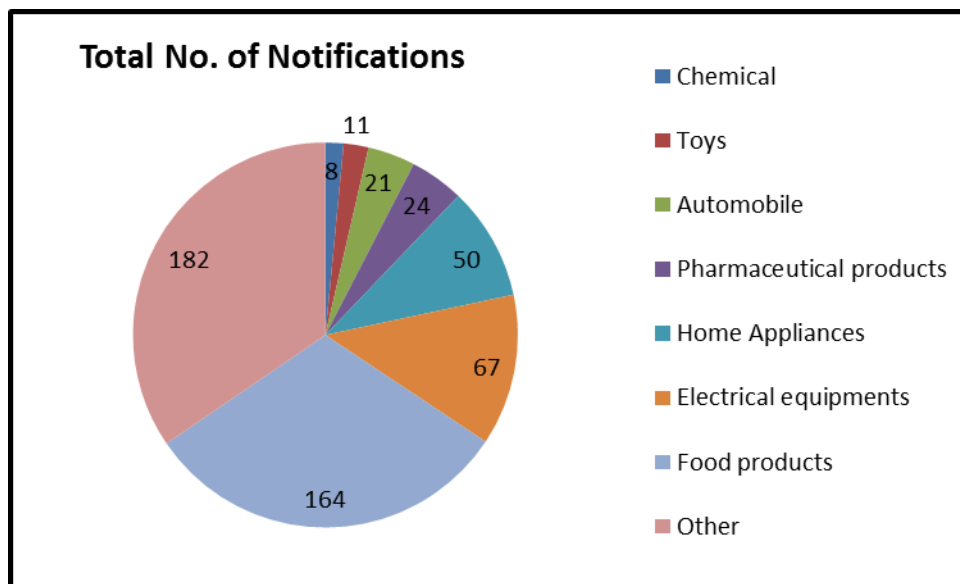

Part II: 1st May 2014 to 31st July 2014

The total number of notifications issued by the various WTO-member countries from 1st of May 2014 to 31st July 2014 was 527. ASL analyzed these notifications to find any market access issues for Indian exporters.



Out of the 527 notifications, 164 were on food, 67 were on electrical equipment, 50 concerned home appliances, 24 were on pharmaceutical products, 21 were on automobile products, 11 were on toys, 8 were on chemicals, and the rest were in respect to textiles, tobacco, gas containers, cosmetics, plastic products, animal products, pharmaceutical products, construction, energy, footwear fuel, furniture, steel, safety device , cosmetics, animal products, seed, fuel , coffee , milk, paint and petroleum so on and so forth.

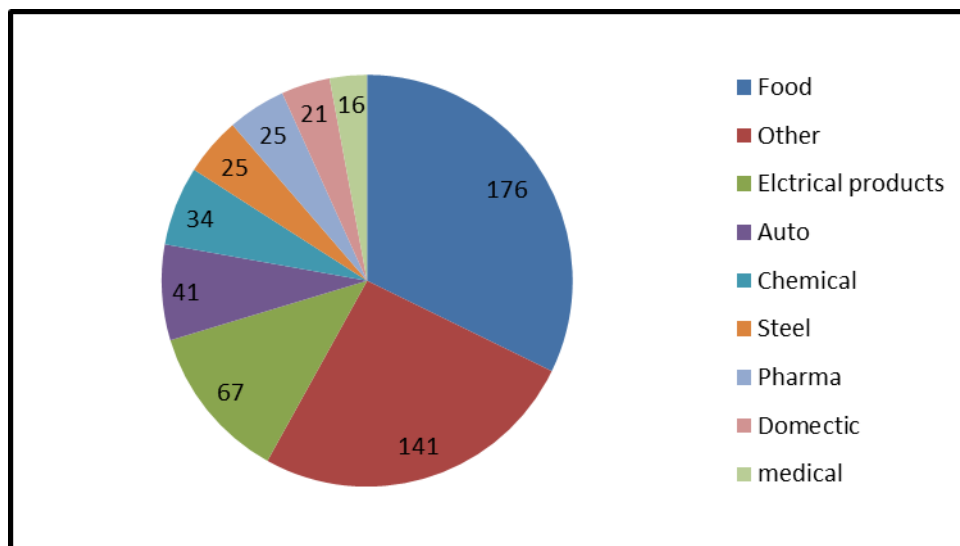

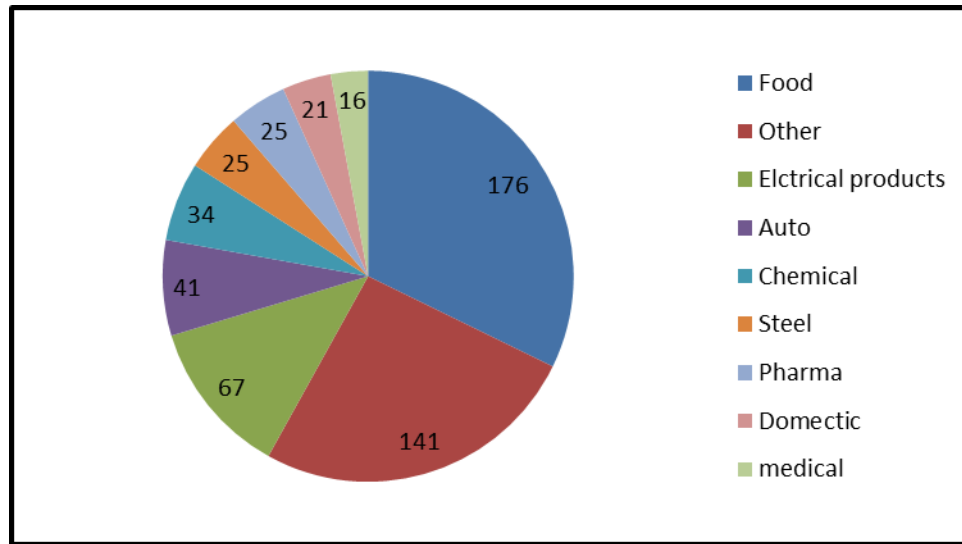
